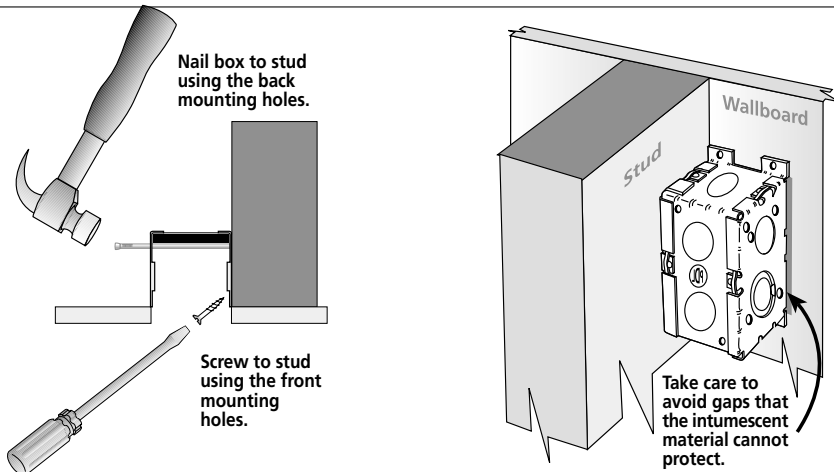




140F FIREPROOF FLUSHBOX

Installation instructions for mounting of 140F Fireproof Flushbox.

MOUNTING OF BOX



Ensure box is firmly attached to the stud.

The hole cannot be any larger than the size of the box opening or sealing will be required.

HOW IT WORKS

The intumescent material expands in the presence of heat to block the path of heat and fumes. The product has been tested with the supplied amount of material so it is vital that no pieces are removed during installation. If cable is required to enter through the back of the box, a slit can be cut in the material (not a hole) and the cable fed through.

SPECIFICATIONS

The 140F Fireproof flushbox has been tested in firewalls with PDL accessories and is rated for upto 2 hours. It has been approved by Branz to AS 1530-4. The earth terminal provided should be used where the electrician considers necessary or in situations in accordance with AS 3000 or NZS 3000 section 5.

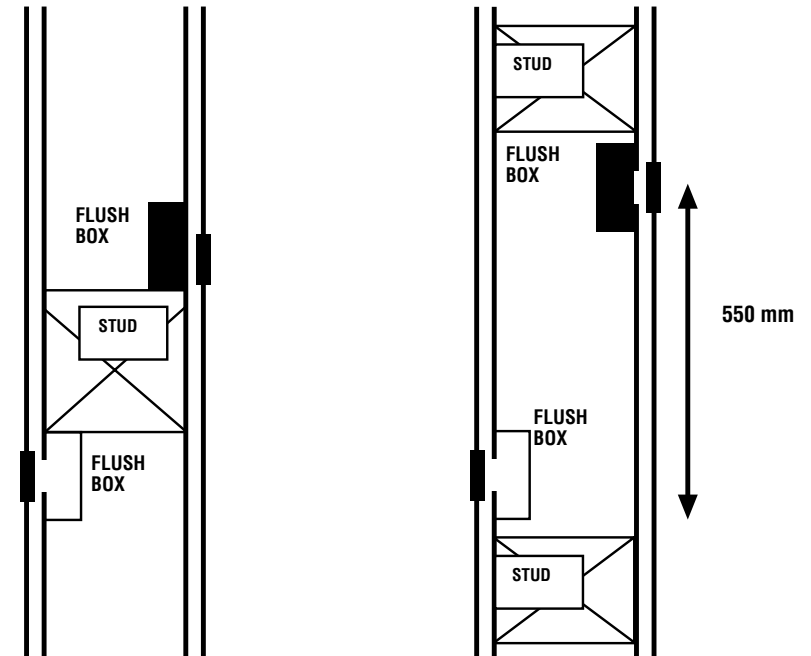
The 140F Fireproof flushbox is generally suitable for use with PDL 500 and 600 series accessories. It is not suitable for the following specific products,

ACOUSTIC RATINGS

In the opinion of Marshall Day Acoustics (NZ Ltd) this flushbox will not degrade the acoustic ratings of all common types of steel and timber framing with STC ratings up to 60. See below for installation instructions.

* Please ensure there is at least 550mm between flush boxes or that the flush box is separated by a stud. See your Sales Representative for more information.



PRODUCT WARRANTY/12 MONTHS

The PDL 140F Fireproof flushbox has a 12-month warranty from the date of purchase providing the unit is installed according to these instructions, local wiring regulations and Codes of Practice. This warranty is void on any unit which has been tampered with, damaged by accident, improper operation or incorrect installation.
