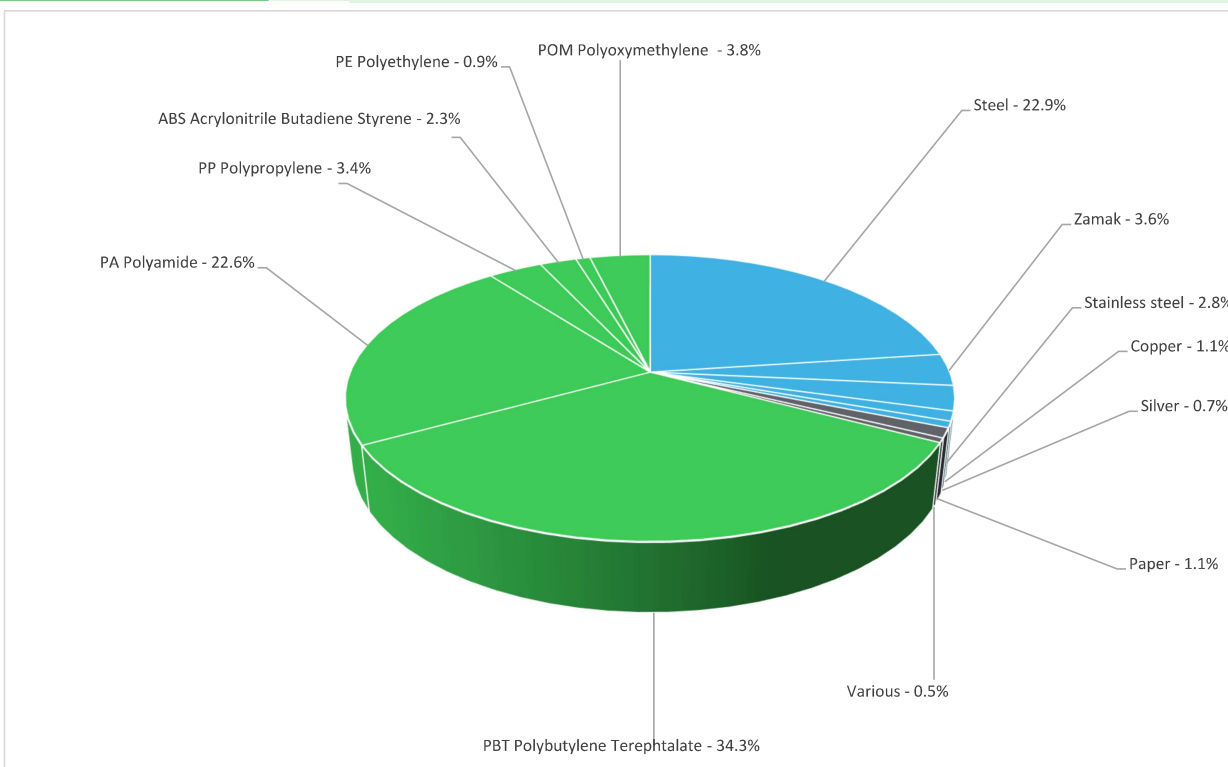


## General information

Functional unit	This selector switch comes with a standard handle and this product has 3 operating positions and operates with a stay-put mechanism. This selector switch provides a versatile interface for controlling machines. It has 2 NO contact with slow-break operation. This is a plastic switch with a metallic-look ring design bezel. This switch primary function is to control devices as well as switch between a minimum of two electrical circuits with a power consumption of 0.004W with use rate of 72% for a period of 10 years and product is adhering to standards IEC 60947-5-1
